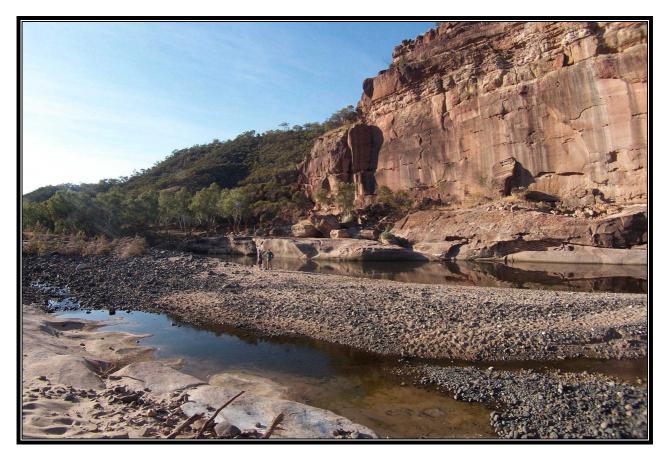

Flinders Shire is situated approximately half way between the cities of Townsville and Mount Isa and is named after Queensland's longest river - the Flinders River. The Flinders Shire is divided by the Flinders Highway - now known as the popular tourist drive 'Overlander's Way'. The Flinders Highway runs east and west through the Kennedy Developmental Road - which runs north and south through the Flinders Shire. Encompassing the townships of Hughenden, Prairie, Torrens Creek and Stamford, Flinders Shire has become a major hub for transports and travellers alike.

KOOROORINYA FALLS

Lt. Stokes of the "Beagle" discovered the Flinders River on July 30, 1841. In 1863 Ernest Henry was the first person in this area to select a pastoral holding which he named "Hughenden Station" after his Grandfather's Tudor Manor in Buckinghamshire, England. It was from this station the township of Hughenden took its name, however it was not officially surveyed until 1867.

The Flinders Shire has a population of 1,997 residents. Its main industries are cattle, sheep grazing and tourism. The Shire has three prominent geological features. Porcupine Gorge in the north, Flinders River which winds from the White Mountains in the north-east through to the west of the Shire. The Shire was also part of a Great Inland Sea and the centre of Dinosaur Country, home to many fossils including the great Muttaburrasaurus and the Queensland Pterosaur.



The Shire has four different bio-regions with ever-changing eco systems including the Desert Uplands, Einasleigh Uplands, Mitchell Grass Downs and a small portion of Gulf Plains.

While maintaining and improving Council's 2279.8km road network consumes a great deal of effort, Council actively strives to provide its residents with high quality sporting, cultural and recreational facilities.

Major events held in the Flinders Shire include the Annual Hughenden Agricultural Show, Hughenden Country Music Festival, Hughenden Campdraft, Porcupine Gorge Challenge, Hughenden Races and PBR Bull Ride as well as country race meetings held at Stamford, Prairie and Kooroorinya Falls Nature Reserve annually. The Shire welcomes over 15,000 visitors annually through the accredited Visitor Information Centre, The Flinders Discovery Centre.

This Centre houses a full skeletal replica of a Muttaburrasaurus as well as the Porcupine Gorge Light and Sound Show, Shearing the Stragglers display and other fossil and gem collections with some historical memorabilia and much more.

MAYOR'S REPORT



The 2009-2010 year continued to be a busy year for our staff with a full Works Program for our outside workforce and additional reporting and planning requirements for our inside staff in addition to their normal duties. I would like to thank the workforce and staff for their attitude and dedication during the year.

The State Government Reform Agenda for Local Government is continuing with the new Local Government Act coming into force on the 1 July 2010. Complying with the new Act and implementing new plans such as the Asset Management Plan and Community Plan has certainly increased the workload on our staff. The reduction in the number of Councillors in this term continues to increase the workload of Councillors as they balance the demands of Council work and their own businesses. We have had Council Meetings with the Mayor and two Councillors present which is not good governance and have had to postpone a meeting for lack of a quorum. This is the first time in my nineteen years on

Council that a quorum has not been present to hold a meeting. We have made representations to the State Government Electoral Act Review Commission to increase the number of Councillors to six.

The upgrade of the Sewerage Scheme in Hughenden was completed during the 2009-2010 year. The project cost approximately \$10.5 million and it is good to have completed the task as it had been planned and lobbied for a number of years. I would like to thank townspeople for tolerating the disruption while this major infrastructure upgrade was occurring around their houses. The project was completed without incurring any debt which is a good result for Council. I would also like to congratulate all staff and contractors for bringing this project to completion.

Road works continue to be a major part of Council business. Work has been completed on the final widening of the Flinders Highway through the Shire. This is in line with Main Roads priority for the Highway which has greatly improved its safety. Sealing works have continued on the Hughenden – The Lynd Road with the Australian Government Strategic Roads to Recovery funding. The current works will result in approximately 115km of this road being sealed. Since the end of the financial year, the State Government has recently announced \$20 million for The Lynd Road, which will seal approximately 70km. This has been a major achievement for the Hann Highway Action Group, Flinders and Etheridge Shires and we will continue lobbying for the full sealing of the road. Further works through the Australian Government Roads to Recovery Program, State Government TIDS funding, Flood Damage and Shire Roadworks have meant that our road construction crews have been fully occupied in the 2009-2010 year. Major work on the Hughenden-Winton Road has begun. The Main Roads construction crew Roadtek is working on this road, where they are using flood damage funds, in combination with the \$23 million of rail maintenance savings to upgrade the road. This road has been deteriorating very quickly and this injection of money should certainly return it to an acceptable state.

The relocation of the Hughenden Rubbish Tip is progressing well. Final plans have been approved by DERM and an access road has been constructed. The work on the tip site will commence early in the new financial year. We are hoping to have access to the new Tip around Christmas.



A number of improvements were made to our Parks during the year to improve the sport and recreation opportunities for our residents. Council contributed to the Outback Arena at the Showgrounds which is an exceptional venue for horse-sports and other events that require a large covered arena. The Playground in Brodie Street has had a major upgrade with a funding contribution from the State Government RLIP Program. The Park has been identified as a younger children's park in our park planning. This theme has been implemented with development which includes play equipment, BBQs and a riding and training area for bicycles. The Skate Park has also benefited from a new shelter over the area, and this will certainly encourage use during hotter times. The parks and gardens in the Shire have been very well maintained by our staff and are very welcoming for people entering Hughenden. Funding has been received to employ a Sport and Recreation Officer which will help our local clubs.

CHIEF EXECUTIVE OFFICER'S REPORT

The 2009-2010 financial year has continued on this extraordinary period of change that is expected to continue for the next few years as the State Government implements the new Local Government Act on the 1 July 2010 along with regulations, Local Laws and various new plans under the State Government's Local Government reform agenda.

With a small team of part time Councillors sharing the work load in representing the community and Council, many challenges have been presented with having fewer members at meetings to present ideas, enter into debate and make decisions without their businesses or work places suffering. The issue of having minimum numbers of Council members available to form a quorum at meetings has also been a challenge.



The high level of contract work to the Main Roads Department has continued to create a significant programming challenge for our construction work force. This challenge of completing a significant roads contracting program along with Council's commitment to upgrading its own road network continues to be met by a dedicated and skilled workforce. Council recognised this need and has implemented a full review of its human resource management system to provide clear direction, training opportunities and career paths to help retain and attract employees.

With the Shire's location at the cross-roads of a number of significant State roads, the short to medium term outlook for a continuation of contract works is very positive. Council's main priority for new construction works on this network is the Kennedy Developmental Road (Hann Highway) - the last section of unsealed road linking Cairns to Melbourne via a truly "Inland Highway". Council along with the community based Hann Highway Action Group continue the Government lobbying process to develop this strategic link. With the currents year's Works Program completed there is now approximately

95 kms of the road sealed with 70 kms remaining to be sealed in Flinders Shire. With an ongoing commitment from the State and Federal Government, Council is planning for the link to be fully sealed in the next 5 - 10 years. This will open up many opportunities for the grazing industry, freight companies and tourism.

The completion of the upgraded Hughenden Sewerage Network was completed on budget at a cost of \$10.5m. RMS Engineering and Construction working under our project manager Base iGi Consulting Engineers did an excellent job in retro-fitting the new system throughout Hughenden. The limited number of complaints and issues within the community was a good indication of how successful this project was completed.

With this upgraded sewerage network in South Hughenden, the infrastructure throughout the Shire is generally in reasonable condition. This includes an excellent water supply system to Hughenden and good supplies to the other small towns. Ongoing challenges include the need to treat our water supplies with chlorine and fluoride to comply with current health regulations, consideration of a sewerage system for north Hughenden and a new tertiary sewerage treatment plant.



Council continues to maintain and upgrade the excellent sport and recreation facilities that include a Multi-Purpose Sports/Entertainment Centre, Swimming Complex, Skate Park, Showgrounds Complex and extensive public parks that provide for most community activities. Ongoing plans for upgraded sport and recreation facilities and the appointment of a Sport and Recreation Officer will ensure that Council continues to work with the community for improved recreational facilities. The Council Local Community Small Grants Scheme continues to provide essential capital funding to local groups to help develop their club recreation facilities.

The tourism industry continues to provide an alternate income stream for many local businesses. The Flinders Discovery Centre with its interpretation of the local area - combined with the development of our local parks with its art works and historical interpretation enables visitors to enjoy the areas culture and charm. The *Eco-Walk on Flinders* - a project that provides walking trails and interpretation of the various bio-regions along a section of the Flinders River park land in Hughenden continues to be further developed with local flora. Council is conscious of the local history and will continue to interpret and create our own unique features to attract tourists into the Flinders River park lands. Council is fully committed to ensuring the continued development of our local geographic features and is working with Queensland Parks and Wildlife to help plan the development and promotion of the unique National Parks in our area.

Hughenden's location on the cross roads of major highways, a quality rail and road network, a developing agricultural industry and significant natural attractions, combined with the traditional grazing enterprises, all points to a positive future for the area. With the increased mining exploration for coal seam gas and thermal coal in the Hughenden region combined with planning for a high voltage transmission line through the mid west and development of the Flinders River Agricultural Precinct will create many opportunities for sustainable development. The region has the opportunity to become the renewable energy capital of Australia with plans for wind, solar and green power generation to take advantage of our natural resources and feed into the proposed new electricity grid. Council's challenge is to continue to help set the scene for development by working with the State and Federal Governments to promote the many opportunities for development.

In a time of global recession Council has been lucky to have a significant Works Program that has created employment opportunities in various roles with Council. The local businesses have also been able to share in this economic stimulus through the extra level of works on roads, buildings and the contractors working on projects in the region.

Council will continue to be challenged with maintaining its long term financial sustainability that will always be an ongoing consideration for Council when planning future developments. With continuing effort by Councillors, employees and the community we will achieve the goals and objectives to make the Shire an enjoyable place to work, play and visit.

HUMAN RESOURCE MANAGEMENT REPORT

The Flinders Shire Council places a high priority in ensuring that it employs a workforce that is responsive to the community's needs. Council recognises that in order to accomplish this, it must invest sufficient funds for training. This ensures that employees are kept up to date with changes to legislation, technology etc. This policy has been successful in that it has built strong relationships between Councillors and employees.

Flinders Shire provides employment to one hundred people in a variety of professions and trades. Teamwork and commitment of the workforce has made many of Council's highlights and achievements possible.

EQUAL EMPLOYMENT OPPORTUNITY

The Council's Equal Employment Opportunity Policy remains unaltered from the previous year. The Flinders Shire is committed to the Equal Employment Opportunity principles. The Equal Opportunity Management Plan aims to implement employment practices that are based on fairness and equity.

CODE OF CONDUCT

The Flinders Shire, in accordance with the requirements of the <u>Public Sector Ethics Act 1994</u>, adopted a Code of Conduct and a Code of Discipline for employees, contractors and consultants in April 1997. The Code of Conduct is now integrated with other Council policies and every employee is provided with a copy of the Code of Conduct at the commencement of employment.

The Code of Conduct is based on these five ethics principles -

- 1. Respect for the law and the system of Government
- 2. Respect for persons
- 3. Integrity
- 4. Diligence
- 5. Economy and efficiency

There were no breaches of this code by any Councillors during the 2009-2010 year.

WORKPLACE HEALTH AND SAFETY

The Flinders Shire is committed to ensuring that a healthy and safe working environment is maintained and that employees are not placed at risk while conducting activities for the Council. Council employs a fully qualified Workplace Health and Safety Officer and has an active Safety Committee.

Council encourages all employees to undertake relevant training. Council is fully aware of the benefits of training employees to help maintain their skills and knowledge. This approach helps to keep employees abreast of the changes in their work environment and relevant legislation and technology.

AUDIT OF THE STRATEGIC ASSET MANAGEMENT PLAN

In conformity with guidelines prescribed by Department of Environment and Resource Management (DERM) an audit of Council's Strategic Asset Management Plan (SAMP) for water supply and sewerage was conducted by LG Infrastructure Services in August 2008 to determine Council's level of compliance with the Plan.

Aspects examined included documentation, methodology, processes, performance, resources and Customer Service Standards for Water Supply and Sewerage.

The SAMP Audit identified that opportunities exist for Council to further develop its asset management capability and regulatory compliance and has the support of management to do so.

Positive aspects of Council's current position include:

- Possession of a compliant SAMP that satisfies Department of natural Resources and Water's requirements for a SAMP;
- Council commitment to funding replacement and development of new sewerage reticulation schemes;
- Achieving a standard of maintenance with the built water and waste water assets considering their age, skills shortages and limited access to funding;
- Awareness of operational requirements of water and sewerage assets and acknowledgement by the Chief Executive Officer and Council staff that the system although sound, would benefit from additional improvements to performance monitoring.



It was recommended that Council develop a simple Asset Management System in order to comply with its statutory obligations. It is envisaged that current gaps in maintenance data will be addressed with the implementation of the new Asset Management System with subsequent improvements to performance reporting in the future.

Further recommendations related to developing Customer Service Standards, development of operations manuals, applicable staff training, capturing staff knowledge electronically and exploring shared services opportunities with neighbouring Shires.

Council supports the recommendations contained in the Audit Report and is applying internal and external resources towards addressing the issues raised. Council is currently compliant with the requirement and is on track to be fully compliant with State Regulations by 31 December 2012.

FINANCIAL REPORT

Revenue

The total revenue received for 2009-2010 totalled \$27.57m. Main roads contracts and recoverable works formed 54% of the Council's total revenue while 24.56% was from operating grants and subsidies. The rates, levies and charges for the year formed 9.77% of Council's total revenue.

Expenditure

Council's total recurrent expenses for 2009-2010 totalled \$25.54m. Main roads contracts and recoverable works formed 67.85%, while Shire roads formed 16.73% of this expenditure.

General

The financial position of Council is sound with reserves of \$3.75m at the 30 June 2010. Council's financial position remains sound as it is debt free.

Overview of Operations

This review of operations for the year 2009-2010 follows the structure of Council's Corporate Plan to provide a summary of progress towards the achievement of those broad objectives developed in consultation with Shire residents and ratepayers. Expenditure on activities with each strategic objective can be found in the financial statements.

Discount

The Council allows a discount of 15% on Council Rates and Charges if the total amount is paid within thirty days of the rate notice being issued.

Borrowing Policy

The Flinders Shire Council is debt free as at the 30 June 2010. Council did not budget to borrow any funds in the 2009-2010 financial year.

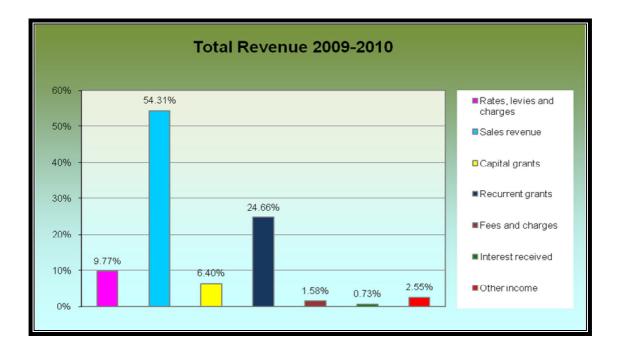

COMMUNITY FINANCIAL REPORT ON COUNCIL OPERATIONS 2009-2010

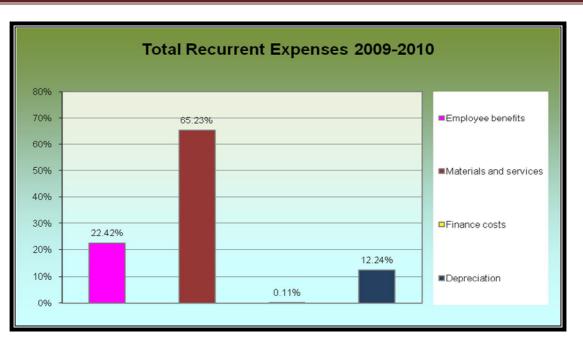
Council finished the 2009-2010 financial years in a balanced position after turning over \$27.57m in total revenue. The following graph illustrates the main revenue sources by line item in the statement of comprehensive income.

This simple view clearly illustrates Council's reliance on sales revenue totalling \$14.98m. A large amount of sales revenue is sourced through contracts and recoverable works from the Department of Main Roads. Government grants totalled \$8.57m. Rates, levies and charges formed only a small part of Council's total revenue.



Total recurrent expenses for the 2009-2010 financial year was \$25.54m. Materials and services amounted to \$16.66m of Council's expenses. Council currently has no debt so finance costs comprise only of bank fees and charges. Employee benefits amount to \$5.72m of Council's expenses. The level of expenditure is reviewed and set in the annual budget, which is constantly monitored throughout the year. Target indicators are set for various departmental sectors and reported to Councillors quarterly via an operational plan.

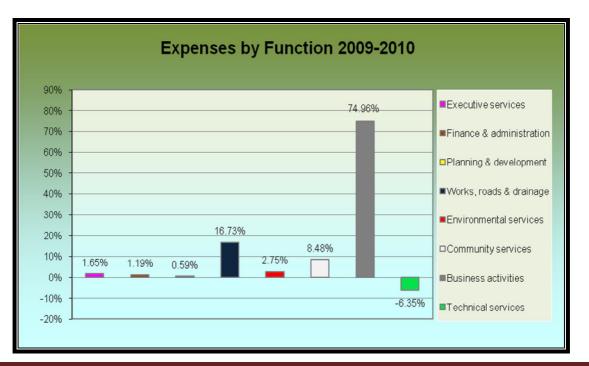




The graph below shows Council's expenses by business function. A significant portion of Council's total recurrent expenses are attributed to the business activities function which comprises water, sewerage, airport, saleyards, Caravan Park, Main Roads contract works, private works and the Flinders Discovery Centre. 90.5% of business activities expense \$19.14m was incurred as a result of Main Roads contract works.

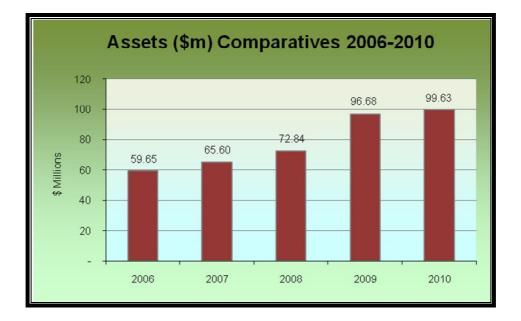
Works, roads and drainage function represents maintenance and construction of Shire roads including flood damage works. Technical services area includes workplace health and safety, store, workshop and depot and plant. The negative indicates that we recovered all expenses through overheads.

The major areas under the community services function include HACC, Community Care Packages, Meals on Wheels, Veterans Home Care, Disability Services, Personal Helpers & Mentors Program, community halls, swimming pool, showgrounds, parks, reserves, skate park, employee housing, aged housing, state emergency services and the library.

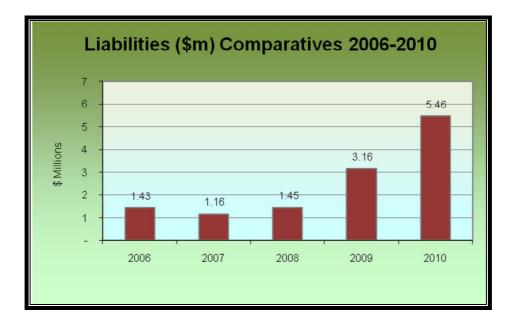




Total assets comprised of \$99.63m, total liabilities of \$5.46m and Council continues to remain debt free. This provides Council with the flexibility to borrow funds for future infrastructure needs. Councils upgraded sewerage reticulation valued at \$10m was capaitalised in 2010. Council also revalued some of its asset classes and a significant impairment was recognised for road assets due to flood damage.



The increase in liabilities is attributable to the increase in main roads construction works and related trade and other payables at the 30 June 2010.

The following ratios help explain the financial position of the Council as at 30 June 2010.

Change in Community Equity Ratio

This ratio represents the percentage change in the net wealth of the Council. The change in community equity is calculated as current year total community equity less prior year total community equity divided by prior year total community equity. The large decrease in community equity in 2010 shows there was little in the ratio for 2009-2010.

Rates Revenue Ratio

This ratio represents the proportion of revenue that is directly sourced from Council's ratepayer base. The rate revenue ratio is calculated as net rates and charges revenue divided by total recurrent revenue.

Equity Ratio

This ratio shows current liabilities as a percentage of convertible current assets. The significant increase in the equity ratio for 2010 was attributed to the of the sewerage assets.

Operating Surplus Ratio

This ratio is an indicator of the extent to which revenues raised cover operational expenses only or are available for capital funding purposes. The operating surplus ratio is the operating surplus (deficit) expressed as a percentage of general and other rates net of (excluding) rebates. The operating surplus ratio is calculated as net operating surplus divided by total operating revenue. Council's decrease in this ratio is a result of accounting for grants received in prior years being in reserves.



Rate Arrears Ratio

This ratio calculates the percentage of net rates and charges receivable to net rates and charges revenue.

Net Financial Liabilities Ratio

This ratio is an indicator of the extent to which the net financial liabilities of Council can be serviced by its recurrent revenue. A ratio of greater than 0 (positive) indicates that Councils total liabilities exceed its current assets. These net liabilities must be serviced using recurrent revenues. A positive value less than 60% indicates Council has the capacity to fund the liabilities and appears to have the capacity to increase its loan borrowings.

Working Capital Ratio

This ratio is not shown in the graph as it is not expressed as a percentage as it measures the extent to which Council has liquid assets available to meet short term financial obligations. The working capital ratio is calculated as current assets divided by current liabilities. The working capital ratio for 2009 was 6.24 times and 3.49 times in 2010. The ratio for 2010 suggests that Council had current assets 3.24 times it current liabilities.
